QUESTION ONE (40 MARKS)

Public Procurement and Asset Disposal Act, 2015 (the Act) came into effect on January, 7th 2016. The Act gives effect to Article 227 of the constitution which provides that public procurement should be conducted in a system that is fair, equitable, transparent, competitive and cost-effective. The Public Procurement Regulatory Authority (PPRA) is responsible for ensuring that the procurement procedures established under the Act are complied with. The Cabinet Secretary, National Treasury, is mandated to prescribe regulations to support operationalization of the Act.
