#### **QUESTION ONE**

(a) After learning that he was supposed to work for Mzungu for the next 10 years without pay, John left his employment with Mzungu without notice. Mzungu was deducting John's whole salary to cater for sponsorship he granted him. When Mzungu learnt about John's departure and his destination, he swore to teach him a lesson. One day he visited John in person and ordered him to go back to his place of work or otherwise "face the consequences." Although John refused to go back these utterances and threats left him restless and feared for his life and security. 1 week later, John was arrested by police officers who flogged him to the police station alleging that he was involved in theft that took place in Mzungu's residence. He was put in remand for 10 days, where he was tortured in order to force him to sign a statement that he was the one who organized the burglary. When John mother came to visit him, she was denied access and was told that she was not to see him for the next 3 years. 2 weeks later, Mwai, the local priest at the church where John's Mother worshiped raised the issue in the church sermon. After the mass, members of the Youth wing in John's Catholic Church went direct to Mzungu residence where they formed a mock court and found him guilty. He was sentenced to an immediate punishment. He was dragged on the road, flogged to the gate where he received 10 strokes while naked. John

was released one day after this incident. On his way home, he was attacked by a group of young men and seriously injured. He was found unconscious the following morning and was taken to Kangu Hospital, a mission hospital in the nearby town. Later in the day, his mother went to check on him and found him missing from his hospital bed. On enquiry, John's mother was informed that John was picked by his uncle

(a whiteman) and transferred to Karia Referral hospital for further medication. Wakabi went direct to that hospital and was informed that they had not received such a patient. It is now three months and John's Mother does not know of his whereabouts.

With the aid of relevant authorities, discuss the issues of criminal process that arise in the case.

(b) Mgumu was arrested on 1<sup>st</sup> January 2023 in Munguni village in Tharak Nithi County. He was alleged to have participated in a theft that occurred in Ikku bar and rest. Last week the prosecutor informed the court that investigations had been concluded and they were now ready to proceed to hearing. Mgumu learns that you are a beacon of hope in criminal matters. He has approached you wanting to know how the hearing will be conducted.

With aid of authorities, give Mgumu a detailed explanation of the processes followed at the trial stage of criminal cases. (8 Marks)
