- f) ICT has a number of impacts in society, which in turn revolutionize the way businesses are done in society. Discuss some of the impacts of ICT in the following areas, and how they have revolutionized the way the society is thinking.

- iii) Suggest TWO strategies each, that the industry would use to achieve their set objectives. (6marks)
