Jacklines husband, Mwenda, hears the crash and rushes to the scene of the accident; he is so shocked at seeing Jacklines injuries that he shortly afterwards develops a psychiatric illness. Explain the essential ingredientsof a negligence action and consider the legal liability of Gladys in the law of Torts. [4 marks]
