- 1. (a) Mastermind tobacco co ltd offered by way of reward of shs. 100,000.00to anyone who contracted influenza after using one of their newly introduced cigarettes as prescribed. The offer stated that they had lodged shs 10,000,000.00 with commercial bank of Kenya to show their sincerity in this matter. John Phillip used the cigarettes as prescribed but that notwithstanding, he contracted (suffered) influenza. He claimed the reward of shs. 10,000.00. mastermind ltd refuses to pay. Can he succeed if he sues them? Give reasons for your answer. [5 marks]
  - (b) Explain defamation and what constitutes defamation. [10 marks]
  - (c) The case of Solomon v. Solomon and company ltd (1897) imports an important principle in business law. Restate the principle and discuss its basic meaning.

  - (d) A sends an invitation to his friend in Chogoria to come to Chuka to play in A's football match against a local team during the weekend. B sends a letter accepting A's offer and travels to Chuka at his own expense. He presents himself to the football field, but A refuses to include him in the team. Can B sue A for breach of contract? Messi is seventeen years old and is offering the piece of land situated in the prime area for only shs 3.4 million. Mr. Mwaniki has already paid 10% of the purchase price and in the course of a friendly conversation, he lets some information about the deal slip to your sharp ears and he decides to give the details of the deal. Advise him on his legal position vis-à-vis that of Messi.
- (b) Discuss five rules of a valid offer.

### **QUESTION 4**

(a) Mr. Mwiti a resident of Maua was travelling from Nairobi to Maua. On reaching Nchiru, the driver of the bus nicknamed MwendaKasi' in a bid to overtake a lorry ahead, rammed into an oncoming trailer causing severe injury to Mr. Mwiti. He was later admitted at the Meru General hospital. The family of Mr.Mwiti spent more than shs. 500,000 as medical expenses and now Mr. Mwiti has been released from hospital and has instructed his advocate who has written a demand letter to Meru star ltd, your input has been sought for by managing director with regard to the demand letter. Remember police officers from Nchiru police station blamed and charged your driver one Mr. Safari for reckless driving.

## **Required:**

- (b) Kariuki entered Jatomy supermarket, picked up one of shopping baskets provided and filled it with groceries from the shelves.
