QUESTION 2

- B offered to purchase a house upon certain, terms, possession to be given on or before 25th July. A greed to the terms, but said he would give possession on the 1st of August. Do we have a contract? (4 marks)
- (b) Michelle in Chuka town wrote to Larry in Meru town offering to sell her BMW for Ksh. 800,000. On receiving Michelle's offered Larry telephoned her in order to accept. Michelle, however, said that since such a large sum of money was involved she wanted a written confirmation of the acceptance from Larry. Larry at once wrote and posted a letter of acceptance at 8 am which Mitchelle had received a better offer for her car, and wrote to Larry withdrawing her offer to him. The letter was posted at 5 pm on a Monday evening and was received by Larry at 8.30 a.m. on Tuesday. Advice on whether a contract was formed.
- (c) X applied for the post of a head master in a school. At its meeting, the meeting committee passed a resolution appointing him to that post. X did not receive any official intimation
- of his appointment, but one of the members of the committee privately informed him about it. The resolution was subsequently rescinded. Can X sue the managing committee for breach of contract? (4 marks)
